Students must have no outstanding disciplinary issues and have all school fees paid.

In order to have a safe and fun filled event, we must have everyone who is planning to attend fill out the contract below by initialling each line item. As a Finneytown Junior or Senior you are encouraged to attend both Prom and After Prom; however you're encouraged to attend After Prom even if you do not attend Prom. **Tickets will not be valid for entry without a signed contract on file. Contracts must be turned into the office or dropped off at 644 Doepke Lane by 8pm on April 21. There will be NO admittance for any student and their date/escort if we have not received a signed contract from them with a parental contact number, even if you are 18 years of age.**

CONTRACT GUIDELINES

_____ I will arrive and remain alcohol and drug free.

_____ I understand that if I do arrive under the influence, I will not be allowed to enter, and my parents will be called immediately to come and get me as I will not be allowed to drive.

_____ **Car keys will be checked in at sign in and returned to you as you leave.**

_____ I understand that if I act in a manner that violates any Finneytown rule in the student handbook at any time during After Prom, my parents will be called and will be asked to immediately pick me up.

PARTY GUIDELINES

_____ **Arrival time is midnight to 12:30 AM.** No one will be admitted after 12:30 AM and for your safety, if you have not arrived by 12:30 AM your parents will be called.

_____ You may leave at any time, but once you leave you may not re- enter. Your parents will be notified if you leave early.

_____ **You must be present to win a prize.** All prizes must be claimed by the person who was drawn. Only Finneytown Seniors and Juniors are eligible for prizes.

_____ You are encouraged to wear casual clothes. Anything that is school appropriate will be permitted at After Prom.
